(herein, "Mid★Am") warrants Mid★Am entry systems for the lifetime of the unit described below to the original purchaser and/or the original homeowner (herein, collectively "owner") of this product should it prove defective by reason of improper workmanship and/or material, the owner shall be entitled to the following so long as such defect was not caused by any modification of the door or door unit, misuse, glass breakage, or deficiencies in building design, construction, installation, or maintenance.

LIMITED LIFETIME WARRANTY EXPLANATIONS:

- 1) Replacement of any defective standard or textured fiberglass slab or sidelight to the owner - for 25 years from date of purchase:
- 2) Replacement of any defective smooth fiberglass, slab or sidelight to the owner – for 25 years from the date of purchase:
- 3) Replacement of any defective 24 gauge steel slab or sidelight to the owner – for 10 years from the date of purchase:
- 4) Replacement of any defective glass in any non-wood slab, sidelight, transom, or round-top to the owner - for 10 years from the date of purchase.
- 5) Replacement of any defective frame component – including frames, sill, brick mould, weather-stripping, and hinges – to the owner – for 1 year from the date of purchase.

This Warranty is effective for all Mid★Am Entry System Door units assembled on or after December 31, 2004.

TO MAKE A CLAIM the owner must submit to Mid★Am in writing within 120 days of notice of the alleged defect(s) a detailed description of the alleged defect(s), as well as, the owner name, address, and telephone number. Mid★Am reserves the right to inspect this product to determine the validity of such a claim. In the event is found to be valid, Mid★Am is not responsible for installation, painting, materials, or other labor and/or costs associated with replacement parts. This warranties contained herein are the owners sole and exclusive remedy under any warranty, contract, negligence, or other claim.

To the extent allowed by law, **MID★AM DISCLAIMS ALL IMPLIED WARRANTIES, INCLUDING THE IMPLIED WARRANTIES OF MECHANABILITY AND FITNESS FOR A PARTICULAR PURPOSE.** Furthermore, to the extent allowed by law, under no circumstances shall Mid★Am be liable to the owner or any other person for any consequential damages, whether arising out of breach of warranty, breach of contract, negligence, or otherwise.
